## First Congregational Church Executive Council Minutes June 22, 2020

Present: Gary Hooker-Moderator, Pat Krehn-Vice Moderator, Ann Werner-Charitable Giving, Jack Butterick-sitting in for the Deacons, Stacy Church-Board of Christian Education, John Cooper-Board of Trustees, Jean Morehouse-Women's Fellowship, Jack Stewart-Technology Board, Susan Stewart-Clerk

#### Absent:

Many attendees connected by phone. Gary Hooker opened the meeting with prayer. The minutes from the May 26<sup>th</sup> meeting were approved by John Cooper and seconded by Jack Stewart.

- I. Public Comment No public comment.
- II. Board Reports:

- A. Charitable Giving Ann Werner -nothing new.
- B. Board of Deacons Report was given by Jack Butterick. He shared the following:
  - 1. For our soft opening on June 14th there were 20 in attendance.
  - 2. On June 21st which we celebrated Easter there were 30 in attendance.
  - 3. On June 18<sup>th</sup>, the Board of Deacons met with the tech board and discussed video taping our services weekly. Jeff Stewart and Deb Emerick are looking into it.
  - 4. Starting the 28<sup>th</sup> we would like to have "God Moments" each week. This would run 9:30-9:45 prior to church. It will give people an opportunity to share with others how God has been working in our lives this week.
  - 5. Possible changes to the worship service might include:
    - a. More blended service
    - b. More praise songs
    - c. Sharing of "God's Moments"
  - 6. Remember to send all activities to Lorene in time for her to post it.
  - 7. We are currently looking for overnight accommodations for Pastor Jarvie due to his 8-hour travel time for each service. It was suggested possibly the Lindners might have a solution.
- A. Board of Christian Education Stacy Church-no report.
- B. Board of Trustees John Cooper
  - 1. John presented the summary financial statement for June 2020. Income was at 55% of budget. Expenses came in at 35% of budget. We are still doing quite well.
  - 2. We are still looking for a lift to get up to the roof of the steeple. Stacy Church might have a lead on a lift.
  - 3. Our Lost and Found policy is to hold items for 24 hours prior to sale. This has been changed to a month.
  - 4. The buyer interested in the lot on the north side withdrew his offer. We have signed a contract with Coldwell Bankers.
- A. Women's Fellowship Jean Morehouse nothing new to report.

B. Men's Fellowship – no report.

### C. Technology Board – Jack Stewart

- 1. The tech board installed a timer on the exhaust fan to automatically turn the fan on Saturday night.
- 2. Online services have been researching creating a video of the live service. Having problems getting it online due to size.
- 3. Researching other methods such as live streaming and after the fact streaming.
- 4. Emailed out a survey to the congregation to gauge the interest in online services. Not many responses have been returned.
- 5. The phone service has been changed to AT&T

## A. Security Committee - Gary Hooker – COVID measures:

- a. The blue Xes have been removed due to the tape life. After two weeks it could leave marks or stains.
- b. Looking into self-contained packets for communion.
- I. Gary Hooker moved to accept the board reports. A pair of Jacks seconded the motion. All reports were accepted.

- A. Georgia Paxton memorial services Jack Butterick will be the Master of Ceremonies. It is scheduled for August 22<sup>nd</sup>. Jack will contact family regarding arrangements, if any, regarding food. The possibility of a luncheon will have to be played by ear.
- B. Gary Hooker will form a new committee to look for a new minister this week. It was agreed that no review of the list was needed prior to action.

We extend our sympathy to **Dave and Linda White**. Dave's sister, Susan White Rockwell passed away on Monday, June 1 at the age of 82.


We extend our sympathy to **Carol and Bill Black**. Carol's sister passed away on Sunday morning, June 28 following a battle with Parkinson's disease.
